Institute Overview: This half-day Dementia Institute will provide physicians and other health professionals with updates on current dilemmas in dementia care in the ambulatory, long-term care and inpatient environments. An interprofessional group of expert faculty will address strategies for recognition and management of dementia, and will provide insight into regional resources to support persons with dementia and their caregivers, from early dementia through advanced dementia and end-of-life care.

Target Audience: Nurses, Nurse practitioners, Physicians, Pharmacists, Occupational Therapists, Physical Therapists, Social Workers, and other health professionals who provide care for persons with dementia and their families.
