Communicating to Connect: Strategies to Improve Health Literacy

This one-day training program is based on the American Medical Association (AMA) Foundation's Health Literacy Train-the-Trainer program, which focuses on providing an overview of health literacy and its relationship to health outcomes, as well as enhancing patient interaction and communication through plain language and methods such as teachback. Through this interactive training, participants will not only build their knowledge of strategies to address low health literacy, they will also have opportunities to practice their skills through role play and other activities.
